- Registration fees must be paid at the time the application is received.

Activity fees are due by August 1st and must be paid before the first day of School in order for the student to attend class.

Financial Responsibility Statement

Providence Christian Academy is a non-profit ministry that relies primarily on timely tuition installments to maintain affordable tuition rates. It is imperative that tuition installment payments are received on time. Payments can be dropped off in the tuition box, paid online, or mailed to 4258 Burrough Drive, Suite 300, Warrenton, Virginia, 20187. Activity fees include: Lab Fees, Testing Fees, and misc items throughout the year.

Payment Policy Tuition/Fees

- Accounts must be kept current
- Registration is due upon receipt of application or re-enrollment
- Tuition must be paid in full or payments may be made in monthly installments (cash, check or charge)
- Activity fees must be paid in full by August 1, 2018 (after this date they must be paid at registration)
- Installments must be made by the 1st of every month, unless balance is paid in full
- After 45 days of non-payment a 7½ % fee will be added to all past due accounts
- After 60 days of non-payment the student will be un-enrolled
- After paying all past due accounts the student will pay a re-enrollment fee of \$60.00
- All accounts must be paid in full by May 15, 2019
- Cost of collection shall be the responsibility of the parents/guardians who sign below
- School records will not be released until all accounts are paid in full
- Students will not be allowed to register for the upcoming year if accounts are not current.

Tuition Discounts:

- Full Tuition is paid on the eldest child. Discount is taken on the youngest child.
 - 5% for 2nd child
 - 15% for 3rd child
 - 25% for 4th child
 - 5th and each additional child is Free
- Full Time Pastor 30%, Part Time Pastor 15%, Active Military 20%, Active Police/Fireman 10%
- Tuition, registration and student fees paid by May 31, 2018 will receive a 5% discount on tuition
- Part-time students receive no discounts

Late Payment Fee/Returned Checks

- A late fee of \$25.00 will be added for payments received after the 5th of the month
- Any check returned by the bank for insufficient funds will necessitate an additional service charge of \$25.00

Refund Policy

- Parents are obligated to pay 10% of the remaining year's tuition if a student is withdrawn after enrolling and accepting an opening.
- Registration and Activity fees are non-refundable.
- Parents will be obligated to pay for the entire month's installment tuition no matter how many days the student attends class in the month he/she is withdrawn.
- Student accounts must be paid in full at the time of withdrawal before the school records will be released.

Sports Fees

• All sport fees are due before the first day of practice.

Tuition Payment Options (One option must be checked)

• PCA student fees: \$100.00.

	PAYMENT IN FULL by 05/31/18 – A 5% discount may be deducted from the annual tuition if payment is received by May 31, 2018. (Full payment includes tuition, registration and activity fees.)
	TWO INSTALLMENTS – August 1, 2018 and January 5, 2019. (This does not include registration and activity fees. Registration fees are due at the time of enrollment; activity fees must be paid before the 1^{st} day of school).
	TEN MONTH INSTALLMENT PLAN – Installments begin August 1, 2018 and conclude May 1, 2019. (This does not include registration and activity fees. Registration fees are due at the time of enrollment; activity fees are due before the 1 st day of school).
	11 MONTH INSTALLMENT PLAN – Installments begin July 1, 2018 and conclude May 1, 2019. (This does not include registration and activity fees. Registration fees are due at the time of enrollment; activity fees are due before the 1 st day of school).
	12 MONTH INSTALLMENT PLAN – Installments begin June 1, 2018 and conclude May 1, 2019. (This does not include registration and activity fees. Registration fees are due at the time of enrollment; activity fees are due before the 1 st day of school).
